Declaration

I acknowledge and agree that:

* My attention has been drawn to the CPYC Fundamental Rule B "Responsibility" which states "It shall be the sole responsibility of each power yacht skipper to decide whether or not to start or to continue in an event".

* The entry of the boat and crew is agreed to and accepted by the South of Perth Yacht Club on the basis that the owner/charterer, his/her skipper and crew are individually aware of and conversant with the risks involved in the sport of time trialing and that the participation in this event is entirely at the risk of the owner/competitor and his/her skipper and crew

* The owner/charterer warrants the suitability of his/her boat for the event.

* The safety of a boat and her entire management including insurance shall be the sole responsibility of the owner/charterer who must ensure that the boat is fully found, thoroughly seaworthy, and managed by a crew of sufficient number and experience who are physically fit. The owner/charterer must be satisfied as to the soundness of the hull and all gear. He/she must ensure that all safety equipment is properly maintained, stowed and in date and that the crew know where it is kept and how it is to be used.

* Neither the South of Perth Yacht Club nor its officers, employees nor agents shall be responsible or liable for any loss, damage death or personal injury however caused to the owner/charterer, his/her skipper or crew or their property as a result of their taking part in the 2008 Time Trialing Season and their related activities, including pre-start and post finish operations and shore activities.

* Neither the South of Perth Yacht Club nor its officers, employees or agents shall be liable for any costs or expenses that may be incurred as a result of special assistance at sea being arranged for any reason whatsoever.

* Neither the existence of these conditions, and their use by the event organisers, or the inspection of the boat pursuant to these conditions in any way limits the absolute responsibility of the owner/charterer.

* The crew have been advised by the owner/charterer to satisfy themselves as to the experience of the skipper and the adequacy of the boat, all safely equipment and insurance arrangements.

I declare that:

* The details submitted herewith are correct and any changes that alter the details submitted herewith will be made in writing to the Sailing Administrator prior to the 1700 hrs on the Wednesday prior an event of the season.

* The boat complies with all local maritime regulations and any alteration to the boat or its equipment that affect the validity of this will render the vessel unable to compete in any events until its compliance is reinstated.

* I will provide each crew member or proposed crew member with a copy of this entry form including a copy of this declaration.

* I and the crew of the boat shall comply with and be bound by the rules & regulations referred to in the CPYC Rules, the Red Book 2008, SoPYC By Laws and any other Supplementary Instructions issued by the Organising Committee.

* The boat and its crew holds adequate insurance and in particular insurance against third party claims at least to the minimum cover of A\$10,000,000 and that such cover will be in force and maintained in full force and effect throughout the SoPYC 2008 Time Trialing Season.
