## FLYING FIFTEEN PRE SEASON REGATTA

### NOTICE OF RACE

**The organising authority is the South of Perth Yacht Club (Inc.)**

**1. DESCRIPTION OF EVENT**

This is a shakedown regatta to get everyone primed for the start of the sailing season. Coaching will be allowed at all times by Race Committee approved coaches.

**2. RULES**

- 2.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing (“rules”).
- 2.2 The prescriptions of Yachting Australia (YA) will apply.
- 2.3 The rules of the International Flying Fifteen Class will apply.
- 2.4 Rule 40 is altered so that it shall always apply to boats racing and display of flag Y is not required.

**3 ELIGIBILITY AND ENTRY**

- 3.1 The regatta is open to all boats of the International Flying Fifteen Class whose skipper and crew are members of a yacht club which is affiliated with YWA.
- 3.2 Eligible boats may enter on the attached Entry Form which shall be lodged with the Race Officer prior to racing.

**4. FEES – Nil**

**5 SCHEDULE**

- 5.1 Registration from 0900 to 0930.
- 5.2 Competitors Meeting 0915.
- 4.3 Warning Signal for race 1 will be 1000. Races 2 – 8 to follow. A lunch break on the land will be allowed for during the day.
- 4.4 Presentation of results will be in the Main Clubhouse at 1800 followed by a BBQ.

**6. SAILING INSTRUCTIONS**

Sailing instructions will be made available at the Competitors Meeting.

**7. RACING AREA**

The racing area will be on Melville Water East on the Swan River adjacent to South of Perth Yacht Club.

**8. THE COURSES**

Windward/leeward and triangular courses are to be sailed as described in the Sailing Instructions. Each race will be 2 laps with a duration of approximately 20 minutes.

**9. PENALTY SYSTEM**

Rule 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

**10. SCORING**

10.1 1 race is required to be completed to constitute a series.

- 10.2 (a) When fewer than 5 races have been completed, a boat's series score will be the total of her race scores.  
(b) When from 5 to 7 races have been completed, a boats series score will be the total of her race scores excluding her worst score.  
(c) When 8 races have been completed, a boats series score will be the total of her race scores excluding her two worst scores.

**11. PRIZES**

There will be a presentation of pennants to Classic, Silver and Open fleets for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup>

**12. DISCLAIMER OF LIABILITY**

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organising authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

**13. INSURANCE**

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$10,000,000 per event or the equivalent.
