



EXPRESSION OF INTEREST

Proposed South of Perth Yacht Club Jetty 4-5 Development

South of Perth Yacht Club is proposing to construct 143 floating pens comprising jetty 4-5. Twenty-eight of these pens will be available to eligible members of SoPYC as Water Pen Deeds ranging in size from 15 metres to 21 metres.

Members and prospective members are invited to lodge an Expression of Interest with SoPYC to register their interest in having a Water Pen Deed allocated to them at the conclusion of the project late in 2015.

The Expression of Interest is subject to a number of conditions:

1. That the Applicant is a Member of SoPYC. Non Members must apply for Ordinary or Family Membership to be considered for a pen. Upon being elected as a member your Expression of Interest will be considered.
2. That a refundable deposit of \$5,000 be lodged with SoPYC upon submitting an Expression of Interest.

The Water Pen Deed deposit will be refunded should:

- Your Membership application be unsuccessful
- Your application for an Water Pen Deed be unsuccessful
- The project does not proceed.
